- Eileen acknowledged soon to be appointed Governing Body member Shannon Steneck and discussed the next steps to having him fully appointed by next Governing Body meeting held September 12th.
- Eileen discussed the past accomplishments for Fiscal Year 2022-2023 along with her shared goals for the Governing Body in the future.
- Eileen brought attention to her Performance Evaluation held by Kimberly Sauceda. Eileen shared her listed areas of improvement based off feedback from said evaluation.
- Eileen handed out copies of the approved SEIU Collective Bargaining Agreement to Governing Body members. This Union contract works towards SF IHSS workers being paid \$25.50 per hour, transportation passes for all Active Registry providers who are currently working, more training opportunities outside of Career Pathways for IP access, and continued funds for PPE efforts in the future.
- Eileen announced the launch of LiveScan waiver pilot has been finalized. LiveScan waiver program allows free DOJ background checkcs for IHSS Providers in San Francisco.

Programs Report – Eren Gutierrez

 Eren Gutierrez (Deputy Director) reported the increased number of LiveScans on a weekly basis due to the pilot launch. Eren spoke on the purpose of LiveScan, in which being, to allow Provider orientation and inperson scanning occur simultaneously, eliminating the financial barrier, and
